CONTRACT FOR PROVISION OF SERVICES PRESS NEWS

Name and organisation of the company « MY NEWS ON LINE »

Subject of the contract: dissemination of recent information published by the various media of the country. (example Spanish NFP)





MYNEWS offers:

A documentary data base « My news on line » that can be accessed on the web www.mynewsonline.com with a login and a personal password, where you can find current information in the basket of the day

This basket service is charged even if we do not take back any news



Contract for Provision of Services Press News My NEWS

Services provided by « My NEWS » are:

- 1.- Follow-up of the information (media, topics selected by the subscriber, thanks to a login and password)
- 2.-Consultation of the data base « My NEWS on line». The subscriber can:
 - Receive this information by e-mail
 - •Consult the website of My NEWS to find the information selected in his-her basket.



Contract for Provision of Services Press News My NEWS

Use of information by the subscriber (HISPAGUA)

- Creation of our own data base fed by My News
- Publication of the news on the Internet

Pricing is based on:

- News displayed by the service operator (CEDEX)
- News published on the website and accessed by the user of HISPAGUA
